Culpeper Town Council makes decisions on matters involving local taxes and utility rates, expenditure of taxpayers' money, community planning and economic development, maintenance of streets and infrastructure, and many other important topics effecting Town residents.

Council members serve four-year terms and each represents the entire town at-large. About half of the Council seats are up for election each odd-numbered year.

Town Council is a nonpartisan body. Candidates for Council are not listed on the ballot with a political party affiliation.
